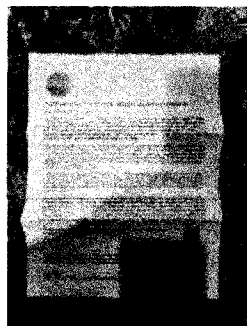

Dear Knightsen Community Services District:

The Enforcement Division of the Fair Political Practices Commission enforces the provisions of the Political Reform Act (the "Act").<sup>1</sup> The Enforcement Division received a complaint alleging that you may have violated the Act's mass mailing at public expense provisions. The complainant alleges:

*The community services district in the town of Knightsen is not acting in the community best interest and is serving thier own agenda to close our CSD. They advertise a feasibility study not making the district cost effect however it was leading because it uses 200K in salary and employee cost never used or budgeted in the history of the district. They also sent out this mass mailer, paid for by CSD which i confirmed with Trish Bello. It is a leading document.*

At this time, we have not made any determination about the allegations made in the complaint. We are requesting information, including documentation, about the allegations described above. **Please submit your response in writing within 14 days** from the date of this letter to Laura Mandler at [lmandler@fppc.ca.gov](mailto:lmandler@fppc.ca.gov), or the address provided above. Upon receipt of your response, we will review the information to determine whether or not to investigate the allegations.
