RESOLUTION 2019 – 3**

BEFORE THE BOARD OF DIRECTORS OF THE KNIGHTSEN TOWN COMMUNITY SERVICES DISTRICT

**A RESOLUTION SETTING THE SPECIAL TAX RATE FOR FISCAL YEAR 2019-2020 FOR CONSTRUCTION,
MAINTENANCE, AND OPERATION OF FLOOD CONTROL AND WATER QUALITY FACILITIES**

WHEREAS, the County of Contra Costa did submit to the qualified voters of the District in a special election on February 15, 2005 a ballot measure levying a special tax for construction, maintenance and operation of flood control and water quality facilities and related administrative costs, and

WHEREAS, said ballot measure was approved by the qualified voters of the District, and

WHEREAS, the Board of Directors of the Knightsen Town Community Services District has now determined in its exercise of reasonable direction and fiscal prudence, that the Special Tax is necessary and required to provide an adequate level of construction, maintenance and operation of flood control and water quality facilities and associated administrative costs during the Fiscal Year 2019-2020.

NOW THEREFORE BE IT RESOLVED, that the Board of Directors of the Knightsen Town Community Services District hereby levies the Special Tax for fiscal year 2019-2020 as follows:

Developed Taxable Parcels: \$50.00 per taxable parcel

Undeveloped Taxable Parcels: \$25.00 per taxable parcel

SECTION 1. The object and purpose of the special tax is to provide a source of funds for constructing, operating, maintaining, and servicing flood control and water quality improvements by the Knightsen Town Community Services District or other public entity.

SECTION 2. The special tax shall be levied on each taxable parcel which received an ad valorem property tax bill within the Knightsen Town Community Services District.

The land use classification to determine each taxable parcels development status shall be based on the most current Contra Costa County secured property tax roll unless other current and verifiable information is made available to the District. The official tax levy roll designating the proposed tax on each parcel shall be on file in the office of the Clerk to the Board of Directors and is incorporated herein by reference.


ON MOTION of Director Gilbert Somerhalder second by Director Linda Matteri the foregoing resolution was passed and adopted this 6th day of June 2019.
